  - ii) UIL Professional Acknowledgement Form: Fill out, print & sign. https://www.uiltexas.org/files/professional-acknowledgement.pdf
  - iii) COVID update: All easements have expired.
  - iv) UIL Office: Some Sight-Reading criteria has been simplified except 6A band added Key of C.
  - v) HB 547 effective 9/1/21: Homeschool students may compete in UIL if your school district allows. https://www.uiltexas.org/policy/homeschool-faq

- v) Middle School Enrollment Form: Due Oct. 1<sup>st</sup>. If your school is now a different classification than listed on the region 21 web site, then print, fill out, get proper signature, and return form to Mike Bullock. - c) All contests are entered through <u>texasmusicforms.com</u>.
  - i) All contests: Payments MUST include an Invoice Form 1A.
  - ii) Vanco/Dorian Systems / Charms/Texas Music Forms are same company.
  - iii) Texas Music Form Profile:
    - (1) Check your profile for accuracy. Write each profile user name and password down so you don't forget.
    - (2) Use the same profile(s) as last year unless you have changed jobs.
    - (3) Must have separate profiles for <u>each division</u> (band, choir, orch) & for <u>each campus</u> (HS, MS or multi-MS) where you take a group to contest.
  - iv) You must enter your campus' <u>TEA code</u> in order to enter any contest. It's NINE digits long. <u>https://tea4avholly.tea.state.tx.us/TEA.AskTED.Web/Forms/SearchScreen.aspx?orgType=School</u>
  - v) S&E: Enter all S&E entries under head director of that campus.
  - vi) MB and C&SR: FMPro is used to randomize all marching & C/SR drawings for order (sequence of groups).
- d) 2022-2023 REGION UIL CONTEST DATES, SITES AND FEES See attachment
  - i) Fees will be \$475/group for all events except HS Marching \$400. S&E fee is \$11/student.
  - ii) **Important:** If UIL Region 21 experiences a budget deficit, all schools will be invoiced a portion of that deficit according to the number of C&SR performing groups.
- e) CONTEST CONFLICTS/REQESTS: If you have a valid schedule conflict/request, justification must be in letter format on letterhead, & signed by the superintendent or principal. Deadline is 30 days before contest.
- 3) NEW BUSINESS:
- 4) REMINDERS FROM SPRING MEETING:
  - a) All contests: Form 1 required
  - b) All contests: Form 1A Invoice required with check. Remember S&E Late Entries & Day-of Late Entries
  - c) All contests: If you are hosting an event, be sure to refer to the new "Host Recommendations" document
  - d) S&E: Don't ask for specific day unless you have major conflict
  - e) S&E: Use correct format for S&E edits
  - f) C&SR: Special schedule consideration requires official letter
  - g) C&SR: Use correct format for concert edits, remember 7-day rule
  - h) C&SR: Don't use A, B, or C for NV's and Sub-NV's unless you have multiple groups. 1<sup>st</sup> group A, 2<sup>nd</sup> B, etc.
  - i) C&SR: Use the blue "Lookup" button for Titles. DO NOT make up PMLID's for anything leave it blank.

- 3) UIL C & CR CHANGES/CLARIFICATIONS/REMINDERS:
  - a) Reminders:
    - i) MB: Physicals should be in place.
    - ii) MB: Everyone helping with the marching band must complete Marching Band Safety Training <u>every year</u>. <a href="https://www.uiltexas.org/music/marching-band-safety-training">https://www.uiltexas.org/music/marching-band-safety-training</a>
    - iii) MB: Remember to complete "Forms to Keep" <a href="https://uilregion21.org/region-marching/forms-to-keep/">https://uilregion21.org/region-marching/forms-to-keep/</a> & "Forms to Submit" <a href="https://uilregion21.org/region-marching/forms-to-submit/">https://uilregion21.org/region-marching/forms-to-keep/</a>
    - iv) MB: Region entry requires declaring an intent to advance AND selection of a track military or open. No band may compete in military AND open class in the same year.
  - b) MB: UIL State Marching Contest:
    - i) Open Class will be held this year for conferences 2A, 4A, & 6A.
    - ii) Military Class will be held for conferences 1A/2A & 4A.
  - c) MB: UIL Non-advancing Area
    - i) Open class will be held this year for conferences 3A & 5A.
    - ii) Military Class will be held for conferences 3A and 5A/6A
  - d) MB: An every-year State Marching Contest is possible for 2023-24.
  - e) MB: NEW C&CR 1105(h)(5)(A) Electronic cables may now cross sidelines. However, students may NOT perform over field cables, covered or not.
  - f) MB: NEW C&CR 1105(h)(5)(B) A non-student may intervene during 8-minute performance clock to address an electronics failure. Written justification must be supplied. ... If justification does not support action, the REC may proceed with ... penalty.
  - g) MB: NEW MB Rules Committee Bands are allowed to check wireless devices ONLY during the 7-minute period that includes a band's 2-minute field exit and a band's 5-minute field entrance, regardless of where you are at the site.
  - h) MB: NEW MB Rules Committee Contests should develop a standardized schedule (across the state) that includes a 45-minute warm-up period.

#### 4) REGION 21 BUSINESS:

- a) MB: An issue arose this summer with SFA holding Region Marching Contest. Region marching will be in Longview bad weather site at Carthage's indoor stadium.
- b) C&SR: Judges are still being hired. The complete list will be posted as soon as the panels fill.
- c) C&SR: MS Zoning Please email Mr. Bullock & let him know if your MS will take more or less bands to CSR. No report is necessary if there isn't a change. Zones will be updated sometimes this fall & will be in effect for two years.
