A partial list of UIL/Region 21 policies

- PLEASE NOTE: If UIL Region 21 experiences a budget deficit, all schools will be invoiced a portion of that deficit according to the number of C&SR performing groups.
- Entries will be considered “Official” at the entry deadline. Entry fee invoice must be sent to business office and a check written at that time. Entry fees will not be refunded or dismissed after the entry deadline.
- 7-Day Rule S&E: Title changes cannot be accepted as free edits past the 7-calendar-day prior-to-contest deadline (C&CR – 1108: (g) (4). After that 7-day deadline, a title change becomes a late entry with late fees incurred.
- 7-Day Rule C/SR: Title changes are not possible past the seven-calendar-day prior-to-contest deadline (C&CR – 1110:(d)(3)(B)
- LATE ENTRY FEES will be assessed as follows:
 - Marching/C&SR – Entry Fee PLUS \$100.00
 - S&E – Entry Fee doubled per student (No charge for names changed to 50% or less of event)
