# AREA C OPEN MARCHING CONTEST UIL Regions 3(3A/4A), 4, 9, 10, <del>19</del>, 21, 25(4A), <del>33</del> GENERAL INFORMATION 2024-2025

The following information is for **2A**, **3A**, **and 4A** band directors who have selected "INTENT to participate" in the OPEN CLASS Area C Marching Contest. Bands that have chosen "Military Class" are not eligible for this "Open Class" contest.

### 2A OPEN CONTEST

<u>DATE</u>: The Area C 2A Contest is scheduled to be on Saturday, November 2, 2024. Although the 2A & 4A contests have been combined in years past at the same site, the two need to be separated because a significant number of 4A bands have been added to Area C. Mineola High School is the 2A site.

<u>WEATHER INTERRUPTIONS</u>: The weather will be monitored with a lightning detector during the contest. The field and stands might have to be vacated. Additionally, there could be a thirty-minute delay, or the contest could be postponed. If we continue to have unsafe weather, we will move to the indoor facility at Lindale High School using the same schedule as much as possible.

<u>2A ESTIMATES</u>: The 2024-26 UIL Reclassification added several bands to Area C 2A. With this in mind, it is estimated there will be about <u>eight</u> 2A Open Class bands at Area out of the fifteen 2A bands that will probably make a first division (includes military). 2a prelim performances should start about 1:00pm and end about 3:00pm. The state UIL office has granted us an ongoing waiver to allow prelims results stand as final results. 2A results will probably be announced at 3:30pm.

#### Remember, this is an ESTIMATE.

## 4A OPEN CONTEST

DATE: The Area C 2A/4A Contest is scheduled to be on Saturday, November 2, 2024, at Lindale High School.

<u>WEATHER INTERRUPTIONS</u>: The weather will be monitored with a lightning detector during the contest. The field and stands might have to be vacated. Additionally, there could be a thirty-minute delay, or the contest could be postponed. If we continue to have unsafe weather, we will move to the indoor facility at Lindale High School using the same schedule as much as possible.

<u>4A ESTIMATES</u>: The 2024-26 UIL Realignment added a number of bands to Area C 4A. With this in mind, it is estimated there will be about <u>twenty-four</u> 4A Open Class bands compete out of the thirty-seven 4A bands that will probably make a first division (includes military). 4A prelims should start about 9:30am and end about 4:45pm. 4A finals should start about 6:45pm and results announced at 10:30pm.

### Remember, this is an ESTIMATE.

#### 3A OPEN CONTEST

DATE: The Area C 3A Contest is scheduled for Saturday, October 26, 2024. Whitehouse HS Stadium the site.

<u>WEATHER INTERRUPTIONS</u>: The weather will be monitored with a lightning detector during the contest. The field and stands might have to be vacated. Additionally, there could be a thirty-minute delay, or the contest could be postponed. If we continue to have unsafe weather, we will delay the contest until the next day.

<u>3A ESTIMATES:</u> The 2024-26 UIL Realignment added several bands to Area C 3A. With this in mind, it is estimated there will be about <u>twenty-one</u> 3A Open Class bands compete out of the thirty 3A bands that will probably make a first division (includes military). Prelims will probably start about 10:00am and end about 4:45pm. 3A finals should start about 6:45pm and results announced about 10:30pm.

## Again, these are ESTIMATES.

THE FOLLOWING IS REQUIRED (MUST BE SUBMITTED WITHIN 24 HOURS, OR THE NEXT SCHOOL DAY IF 24 HRS FALLS ON SUNDAY OR A HOLIDAY):

- Text or email me immediately after your contest <u>whether or not</u> your band will be coming to Area.
- Signed <u>AREA OFFICIAL ENTRY FORM</u> This form also serves as invoice. (available on Region 21/Area C web site)
- AREA (ANNOUNCER'S) UIL MARCHING BAND SCRIPT (available on Region 21/Area C web site)
- UIL MARCHING BAND EDUCATIONAL USE VIDEO AGREEMENT (email receipt)

### **GENERAL INFORMATION**

- 1. The contest will be conducted according to the rules of the *UIL Constitution & Contest Rules*. Please read and understand the rules prior to attending the contest. Directors should review Section 1106: Area Marching Band Contest, as posted on the UIL State web site.
- After making a first division (certification) at Region, directors must immediately text or otherwise notify Mike Bullock whether or not they plan to attend Area, and submit official entries within 24 hours or by the following school day in case 24 hour falls on Sunday or a holiday.
- 3. The contest schedule should be posted the third day after the final Region Contest (if timely notification by directors of all certified bands is made.) The order of bands is determined by a combination of the FileMaker Pro randomize tool and distance.
- 4. Admission for all spectators is \$8.00 per person. Tickets may be purchased at the gate with cash. Bus drivers & school administrators will be admitted free with presentation of school ID. <u>UIL Athletic</u> passes are not accepted. Children 6 and under are free. Band chaperones must have chaperone passes. Passes (hand stamps) will be available when you arrive at contest. Please limit these complimentary passes to your bus chaperones. Each band student and departing spectator must have his/her hand stamped for reentry into the stadium. This is also necessary if the 2A/4A contest is at two sites; only one admission is necessary for both sites.
- 5. <u>Contest Timing</u> is where bands will be most vulnerable for a mandated disqualification. Please review the C&CR rules regarding timing. Details of the timing procedures are included in Local Ground Rules (*posted on Region 21 Area C web site*). We will operate on a 15-minute performance schedule and 45-minute warm-up schedule.
- 6. Video will be provided by MEDIA SERVICES of Lufkin. All bands will receive a video.
- 7. Prelim comments, recordings, and results will be available to directors via <u>Competition Suite</u> and as UIL rules governing contest software dictates. Video might be on a jump drive, so bring proper equipment if you would like to view your performance.
- 8. <u>Prelim Verification</u>: There will be a break at the end of Prelims. At this time, <u>one</u> director from each band will meet to review the ranking of the bands. All protests must be made prior to the announcement of the results. **NEW for 2024**, there will be a top-half/bottom-half draw for area finals. For example (with a 10-band scenario), bands that are ranked 6-10 in prelims will be the first five performance slots in finals. Bands that rank 1-5 in prelims be the last five performance slots in finals.
- 9. After Prelims, the Drum Majors of all bands will assemble on the press box side of the field during this tabulation time. Drum Majors should be in full uniform. All bands will be introduced and presented a participation plaque, then bands that will be advancing to the Finals will be announced.
- 10. At the end of Finals, we will have a RETREAT of finalist bands. During retreat, <u>one</u> director from each band will meet to review the ranking of the bands. That director will <u>not</u> be able to be with their band during retreat. More info will posted as soon as it is available. All protests must be made prior to the announcement of results. Finals ranking and those bands advancing to State will then be announced.
